1. On 20 June 2025, Victims' Counsel filed his Second SIH Motion¹ whereby he: (i) submitted additional SIH material from victims participating in the proceedings ('VPPs'); and (ii) requested an extension of time to 18 July 2025 to file all remaining SIH material.² On 1 July 2025, Victims' Counsel filed his Third SIH Motion³ in which he submitted additional SIH material from VPPs and reiterated the request for an extension of time.

2. The Specialist Prosecutor's Office ('SPO') does not oppose Victims' Counsel's request for an extension of time until 18 July 2025. With regard to the SIH material submitted pursuant to the Second SIH Motion and Third SIH Motion, the SPO takes the same position as outlined in its Consolidated Response.⁴
