THE PRESIDENT of the Specialist Chambers (“President”), noting Article 33(1)(c) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor’s Office, Rules 77, 82(4), 169 and 170(2) of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers (“Rules”) and Rules 3 and 4 of the Rules on the Assignment of Specialist Chambers Judges from the Roster of International Judges (“Rules on Assignment”), herewith assigns a Court of Appeals Panel following the issuance by Trial Panel II of the “Decision on Joint Defence Request for Leave to Appeal Decision on the Admission of Expert Evidence of Witness W04875” (“First Decision Granting Leave to Appeal”),¹ “Decision on Joint Defence Consolidated Request for Leave to Appeal Decisions on the Admission of Expert Evidence of Witnesses W04826 and W04874 (F03201 and F03203)” (“Second Decision Granting Leave to Appeal”),² “Decision on Joint Defence Request for Leave to Appeal Decision on Prosecution Motion for Admission of Documents concerning Murder Victims and Related Request” (“Third Decision Granting Leave to Appeal”),³ and “Decision on Joint Defence Request for Certification to Appeal the Decision on SPO Motion for Admission of W04747’s Evidence Pursuant to Rule 155” (“Fourth Decision Granting Leave to Appeal”, Collectively “Decisions Granting Leave to Appeal”).⁴

I. PROCEDURAL BACKGROUND

1. On 27 May 2025, Trial Panel II rendered the “Decision on the Admission of Expert

Evidence of Witness W04875,”⁵ “Decision on the Admission of Expert Evidence of W04826 (‘F03201’),”⁶ and “Decision on the Admission of Expert Evidence of W04874 (‘F03203’).”⁷

2. On 29 May 2025, Trial Panel II issued the “Decision on Prosecution Motion for Admission of Documents concerning Murder Victims and Related Request”.⁸

3. On 3 June 2025, the Defence of Hashim Thaçi (“Mr Thaçi”), Kadri Veseli (“Mr Veseli”), Rexhep Selimi (“Mr Selimi”), and Jakup Krasniqi (“Mr Krasniqi”) filed the “Joint Defence Request for Leave to Appeal Decision on the Admission of Expert Evidence of Witness W04875 (F03202)”,⁹ and “Joint Defence Consolidated Request for Leave to Appeal Decisions on the Admission of Expert Evidence of Witnesses W04826 and W04874 (F03201 and F03203)”.¹⁰

4. On 5 June 2025, the Defence of Messrs Thaçi, Veseli, Selimi and Krasniqi filed the “Joint Defence Request for Leave to Appeal Decision on Prosecution Motion for Admission of Documents concerning Murder Victims and Related Request (F03211)”,¹¹ and the “Joint Defence Request for Certification to Appeal the Decision on

5. On 1 July 2025, Trial Panel II issued the First Decision Granting Leave to Appeal, Second Decision Granting Leave to Appeal, Third Decision Granting Leave to Appeal and the Fourth Decision Granting Leave to Appeal wherein, *inter alia*, it granted in part the Defences' requests.¹³

II. ASSIGNMENT

6. Having considered the criteria set forth in Rule 4 of the Rules on Assignment, including relevant experience and expertise as well as availability of Judges at this time,


