## I. INTRODUCTION

1. Pursuant to previous instruction by the Court of Appeals Panel,¹ the Defence for Messrs. Thaçi, Veseli, Selimi and Krasniqi ("the Defence") hereby requests approval to file one consolidated appeal encapsulating the Five Issues certified for appeal in Trial Panel II's Decisions F03297,² F03298,³ F03299,⁴ and F03312⁵ and for an increase in word count ("Request").

## II. SUBMISSIONS

- 2. Each of the Five Issues certified for appeal concern similar issues concerning the interpretation and application of Rule 149.6 In light of the overlapping Issues, to avoid unnecessary repetition, and in the interests of efficiency and expediency, the Defence submits that good-cause exists for the Defence to file one consolidated appeal.
- 3. Further, the Defence requests a word extension of an extra 6,000 words. Should the Panel grant the above Request, the Defence will be addressing arguments concerning Five Issues. The Defence submits that an extension of double the word count in one consolidated appeal will be considerably more accommodating to all Parties than four<sup>7</sup> separate appeals of 6,000 words each
