1. On 25 March 2024, the Single Judge issued the Decision on Victims' Counsel's Request to Set a Date for the Payment of Reparations and other Matters ('Decision').<sup>1</sup> In the Decision, the Single Judge ordered the Registrar to conduct an indigence assessment of Mr Salih Mustafa ('Mr Mustafa').<sup>2</sup>
2. On 10 October 2024, the Register filed a request with the Single Judge to issue orders for obtaining additional information and documentation from [REDACTED], which are required for the indigence assessment of Mr Mustafa.<sup>3</sup>
3. On 16 December 2024, the Single Judge issued a decision on the above request together with five orders to [REDACTED] for the purpose of the indigence assessment ('Decision of 16 December 2024').<sup>4</sup> The Single Judge issued orders to the following [REDACTED]:
  - a. [REDACTED] ([REDACTED]);
  - b. [REDACTED] ([REDACTED]);
  - c. [REDACTED];
  - d. [REDACTED]; and
  - e. [REDACTED].<sup>5</sup>
4. The Registrar was instructed to submit a comprehensive report on Mr Mustafa's indigence by Friday, 28 February 2025.<sup>6</sup>
5. Pursuant to Rule 23(2) of the Rules<sup>7</sup> and the Decision of 16 December 2024, the Registrar hereby reports to the Single Judge on the execution of the orders and the

information received. The responses received are filed on the record as annexes, together with relevant translations, where necessary.

[REDACTED].<sup>16</sup> The Single Judge indicated that such an application can be submitted by [REDACTED], who was to ordered to convey any information collected in this regard, including a copy of [REDACTED] together with the application.<sup>17</sup> In its previous report, the Registry informed the Single Judge that by 28 May 2024, [REDACTED].<sup>18</sup>

10. In its response of 30 January 2025, [REDACTED] informed the Registry that it [REDACTED], and provided [REDACTED].<sup>19</sup>

11. On 3 and 4 February 2025, [REDACTED] provided to the Registry a number of documents, including a copy of [REDACTED], and requested [REDACTED].<sup>20</sup> Pursuant to the Single Judge's Decision, [REDACTED] is also annexed.<sup>21</sup>


## VII. INDIGENCE ASSESMENT REPORT AND REQUESTED RELIEF

15.
