THE PRESIDENT of the Specialist Chambers ("President"), noting Articles 33(1)(d), 33(6) and 48(6) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office ("Law"), Rule 193 of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers and Rules 3 and 4 of the Rules on Assignment of Specialist Chambers Judges from the Roster of International Judges ("Rules on Assignment"), herewith assigns a Supreme Court Panel to decide on the "Defence Request for an Extension of Time and Word Limit for its Request for Protection of Legality" ("Request").1

## I. PROCEDURAL BACKGROUND

1. On 16 July 2024, Trial Panel I rendered the "Trial Judgment", wherein it, *inter alia*, convicted Pjetër Shala ("Mr Shala") of the war crimes of arbitrary detention, torture and murder, and sentenced him to a single sentence of 18 years of imprisonment, with credit for time served.<sup>2</sup>

2. On 14 July 2025, the Court of Appeals Panel issued the "Appeal Judgment" wherein it, *inter alia*, affirmed Mr Shala's conviction, in part, for the war crimes of arbitrary detention, torture, and murder, and set aside Mr Shala's single sentence of 18 years imprisonment imposed by the Trial Panel and reduced it to a single sentence of 13 years, with credit for time served.<sup>3</sup>

3. On 23 July 2025, the Defence for Mr Shala filed the Request before the President.
