- 1. In his Decision on 25 March 2024, the Single Judge assigned by the President to monitor and oversee the implementation and execution of the Reparation Order¹ by the Registrar, ordered that once certain funds of Mr Mustafa have been received by the Registrar, she shall consult with Victims' Counsel as to the most efficient manner to deliver the funds allocated to each victim, on a *pro rata* basis, in accordance with the Reparation Order.²
- 2. On 19 July 2024, the Registrar informed the Single Judge that the disbursement of the received funds had been distributed *pro rata* to the seven (7) participating victims.³ Annex 1 included a table detailing the *pro rata* amounts distributed to each of the victims.⁴ A confidential redacted version of Annex 1, for distribution also to Victims' Counsel, was filed on 25 October 2024.⁵
- 3. The Registry hereby files corrected versions of the table, to correct inadvertent mistakes indicated in the total amounts remaining to be paid (final column).
- 4. Pursuant to Rule 82(3) and (4) of the Rules,⁶ this submission is filed as confidential and *ex parte*, for distribution to the Single Judge, Registrar and Victims' Counsel only. The Registrar has no objection to the reclassification of this filing as public.
