1. On 21 July 2025, the Krasniqi Defence (“Defence”) filed a list of proposed exhibits that the Defence intended to rely on during the presentation of its case.<sup>1</sup>
2. In accordance with the order of the Trial Panel,<sup>2</sup> on 15 August 2025, the Defence filed a Revised Exhibit List.<sup>3</sup>
3. On 15 September 2025, the Defence submitted its first application for admission of material through the bar table, including a related request to add to the Revised Exhibit List the translations of two items tendered therein.<sup>4</sup> The Trial Panel granted the Request on 16 October 2025, and ordered the Defence to file its amended Exhibit List.<sup>5</sup>
4. Pursuant to the First Krasniqi BTM Decision and Rule 119(2) of the Rules,<sup>6</sup> the Defence submits in Annex 1 the Amended Exhibit List.<sup>7</sup>
