THE PRESIDENT of the Specialist Chambers (“President”), acting pursuant to Articles 25(2), 33(1)(b) and 40(1) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor’s Office, Rules 98(3) and the third sentence of 115(1) of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers (“Rules”) and Rules 3 and 4 of the Rules on the Assignment of Specialist Chambers Judges from the Roster of International Judges (“Rules on Assignment”), herewith assigns a Single Trial Judge following the “Notification Pursuant to Rule 98(3) of the Rules of Procedure and Evidence” by the Pre-Trial Judge, that a complete case file of the present case will be ready for transmission to a Trial Panel on 12 November 2025 (“Notification”).¹

I. PROCEDURAL BACKGROUND

1. On 29 November 2024, the Pre-Trial Judge confirmed the indictment against Messrs Hashim Thaçi, Bashkim Smakaj, Isni Kilaj, Fadil Fazliu and Hajredin Kuçi, a redacted version of which was made public on 6 December 2024.²

2. On 5 December 2024, Messrs Bashkim Smakaj, Isni Kilaj and Fadil Fazliu were arrested in Kosovo pursuant to an arrest warrant issued by the Pre-Trial Judge³ and were transferred to the Detention Facilities of the Specialist Chambers in The Hague, the Netherlands, on 6 December 2024.⁴ On 5 December 2024, Mr Kuçi was served a

summons to appear⁵ and Mr Thaçi was served a warrant of arrest.⁶

3. On 11 November 2025, the Pre-Trial Judge filed the Notification.

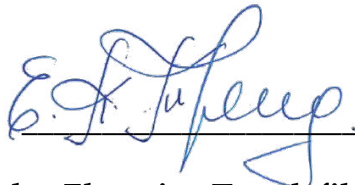
II. ASSIGNMENT
