1. Further to the Registrar's submissions of 17 November 2025,¹ pursuant to the Pre-Trial Judge's Decision F00539 and her clarifications of 12 November 2025,² the Registrar hereby notifies the Single Trial Judge of the following.
2. On 21 November 2025, [REDACTED] ('External Forensic Company' or 'EFC') sent a letter to the Registry focal points³ in relation to the detailed report interpreting the newly compiled spreadsheet of (filtered) metadata, which the Pre-Trial Judge instructed should be prepared by the EFC by Friday, 28 November 2025.⁴ [REDACTED].⁵ The EFC also notes that it has already provided a document [REDACTED], which was again filed on the record ('Existing EFC Report').⁶ Consequently, the EFC states that the Existing EFC Report can be used to interpret [REDACTED] the newly created spreadsheet, pursuant to Decision F00539.
3. Finally, the EFC requests to be informed if the Existing EFC Report is considered insufficient for the purposes of Decision F00539.
