THE PRESIDENT of the Specialist Chambers (“President”), noting Article 33(3) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor’s Office (“Law”) and Rules 3 and 4(2) of the Rules on the Assignment of Specialist Chambers Judges from the Roster of International Judges (“Rules on Assignment”), herewith assigns a Constitutional Court Panel to rule on the “Referral to the Constitutional Court Panel on the violation of Mr Hashim Thaçi’s fundamental rights” (“Referral”).¹

I. PROCEDURAL BACKGROUND

1. On 29 November 2024, a Pre-Trial Judge confirmed, in part, an indictment against Mr Thaçi and four co-accused, for offences against the administration of justice and public order concerning alleged interference in Case 06 before Trial Panel II, in which Mr Thaçi is also an accused.²

2. On 28 October 2025, a Court of Appeals Panel denied an appeal of Mr Thaçi challenging the assignment of the Pre-Trial Judge in this case for offences against the administration of justice.³

3. On 29 December 2025, Mr Thaçi filed the Referral, which was distributed on 30 December 2025.⁴


