I. INTRODUCTION

1. Pursuant to the Pre-Trial Judge's Decision F00382 [REDACTED],¹ Mr Hashim Thaçi ('Mr Thaçi') is restricted from receiving visits at the Detention Facilities from Mr Artan Behrami, Mr Blerim Shala, Mr Ismail Syla, Mr Vllaznim Kryeziu, [REDACTED], Mr Milaim Ahmetaj, Mr Milaim Cakiqi, Mr Avni Kastrati, and [REDACTED] ('Restricted Individuals'); and prohibited from having non-privileged visits with [REDACTED], a Defence team member, in the presence of third parties (collectively, 'Modified Conditions').

2. Pursuant to Decision F00382 [REDACTED],² the Registrar hereby submits the following third report on the implementation of the Modified Conditions, to inform the Single Trial Judge of the implementation of the Modified Conditions since the Registrar's Second Report [REDACTED]. [REDACTED].

II. PROCEDURAL HISTORY

3. In compliance with Decision F00382, the Registrar filed on 24 September 2025 her first report on the implementation of the Modified Conditions, and on 24 November 2025 filed her second report thereon.³ The Registrar hereby incorporates the procedural history outlined therein.⁴
