THE PRESIDENT of the Specialist Chambers (“President”), noting Articles 33(1)(c), 41(10) and 45(2) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor’s Office, Rules 58(1) and (2), 82(4), 169 and 170(1) of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers and Rules 3 and 4 of the Rules on the Assignment of Specialist Chambers Judges from the Roster of International Judges (“Rules on Assignment”), herewith assigns a Court of Appeals Panel to decide on the “Selimi Defence Appeal against Decision on Periodic Review of Detention of Rexhep Selimi (F03699)” (“Appeal”).¹

I. PROCEDURAL BACKGROUND

1. On 16 March 2026, Trial Panel II issued the “Decision on Periodic Review of Detention of Rexhep Selimi”, wherein, *inter alia*, it ordered Mr Rexhep Selimi’s (“Mr Selimi”) continued detention.²

2. On 26 March 2026, the Defence of Mr Selimi filed the Appeal.

II. CLASSIFICATION

3. The Appeals is classified as strictly confidential and the present decision will therefore bear the same classification in accordance with rule 82(4) of the Rules, until it is reclassified in due course consistent with Rule 3(4) of the Rules on Assignment.


