1. Pursuant to Rule 26(1) of the Rules¹ and Section 18(6) of the Directive on Counsel,² the Registrar hereby informs the Trial Panel of the termination of Ms Rudina Jasini's ('Ms Jasini') appointment as Co-Counsel for Mr Rexhep Selimi ('Mr Selimi').
2. On 27 March 2026, Counsel for Mr Selimi, Mr Geoffrey Roberts, sent a letter to the Head of the Defence Office stating that he decided to terminate Ms Jasini's contract as Co-Counsel for Mr Selimi with immediate effect.³ Pursuant to Section 18(6) of the Directive on Counsel, Counsel informed the Defence Office that the termination of Ms Jasini's contract would be accomplished without adverse effect on the interests of Mr Selimi and the duration of the proceedings.
3. On 7 April 2026, the Registrar confirmed the termination of Ms Jasini's contract as Co-Counsel for Mr Selimi in accordance with Section 18(6) of the Directive on Counsel.⁴
