## Request for reclassification

- 1. On 12 June 2020, the Pre-Trial Judge confirmed<sup>1</sup> an indictment against Salih MUSTAFA.<sup>2</sup>
- 2. At that time, the Pre-Trial Judge also granted a request for non-disclosure of the confirmed indictment to the public, pending further order.<sup>3</sup> The Specialist Prosecutor's Office ('SPO') hereby requests reclassification of the Redacted Confirmed Indictment as public immediately following Mr MUSTAFA's transfer by the Registrar to the Kosovo Specialist Chambers detention facilities in The Hague.
- 3. The SPO further confirms that it has no objection to the reclassification, as public, of the Arrest Warrant<sup>4</sup> and Transfer Order.<sup>5</sup> It is, however, noted that it may be appropriate for certain personal details to be redacted from any public versions of each of those documents.<sup>6</sup>
- 4. This filing is strictly confidential and *ex parte* in accordance with Rule 82(4).
