THE PRE-TRIAL JUDGE,<sup>1</sup> pursuant to Articles 21(2) and 39(6) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office ("Law") and Rules 82(5) and 88(2) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers ("Rules"), hereby issues the following order.

## I. PROCEDURAL BACKGROUND

- 1. On 14 February 2020, the Specialist Prosecutor submitted for confirmation a strictly confidential and *ex parte* indictment together with evidentiary material in support of the factual allegations and a detailed outline linking each item of evidentiary material to each allegation.<sup>2</sup>
- 2. On 28 February 2020, the Pre-Trial Judge ordered the Specialist Prosecutor's Office ("SPO") to file, *inter alia*, a revised indictment by 18 March 2020.<sup>3</sup>
- 3. On 18 March 2020, the SPO submitted a revised indictment for confirmation.<sup>4</sup> A further revised indictment was submitted on 20 March 2020.<sup>5</sup>
- 4. On 12 June 2020, the Pre-Trial Judge issued the "Decision on the Confirmation of the Indictment Against Salih Mustafa" ("Confirmation Decision"),6 the "Decision on

Request for Arrest Warrant and Transfer Order",7 and the "Decision Authorising Search and Seizure".8

- 5. On 19 June 2020, the Specialist Prosecutor submitted the Confirmed Indictment,9 with redactions as authorised by the Pre-Trial Judge.<sup>10</sup>
- 6. On 24 September 2020, Salih Mustafa ("Mr Mustafa" or "Accused") was arrested and transferred to the detention facilities of the Specialist Chambers ("SC") in The Hague, the Netherlands.<sup>11</sup>

## II. APPLICABLE LAW

- 7. Pursuant to Articles 21(2) and 39(6) of the Law, hearings shall be public, unless the Pre-Trial Judge decides otherwise in accordance with the Rules.
- 8. Pursuant to Rule 82(5) of the Rules, where the basis for reclassification no longer exists, whoever submitted the original filings shall apply to the Panel for reclassification. A Panel may also reclassify a filing upon request by any other participant or proprio motu.
- 9. Pursuant to Rule 88(2) of the Rules, the Panel may, inter alia for security reasons, order the temporary non-disclosure of the Confirmed Indictment and related documents or information to the public, until further order.

III. DISCUSSION

10. Considering that Mr Mustafa has been arrested and transferred to the detention

facilities of the SC, and is due to appear before the Pre-Trial Judge for his initial

appearance, it is necessary to review the classification of certain filings in the case file,

in order to adhere to the principle of publicity of proceedings, which extends beyond

hearings in the courtroom to cover also filings and any other submission in the case

file.

11. In so doing, regard must be paid, on the one hand, to the right of the Accused to

a public trial, as enshrined under Article 21(2) of the Law, and the duty of the Pre-

Trial Judge to provide for the protection of victims and witnesses, including their

safety, physical and psychological well-being, dignity and privacy, as stipulated by

Article 23(1) of the Law.

12. Consequently, the Pre-Trial Judge has the responsibility to ensure that any given

filing in the case file bears the appropriate classification and may, accordingly,

reclassify any filing proprio motu or upon request, should the basis for the current

classification no longer exist.

13. The Pre-Trial Judge intends to reclassify as public the following strictly

confidential and ex parte filings in case file KSC-BC-2020-05, considering that

Mr Mustafa is in the custody of the SC and that no sensitive information

compromising the safety and security of witnesses is contained therein:

• F00006, Pre-Trial Judge, "Order Setting Target Date for a Decision Pursuant to
