1. Pursuant to Rules 26(1) of the Rules<sup>1</sup>, the Registrar hereby informs the Pre-Trial Panel of the conditional assignment of Counsel to Mr Salih Mustafa ('Mr Mustafa').
2. On 24 September 2020, the Registrar assigned Mr Julius von Bóné as Duty Counsel to Mr Mustafa.<sup>2</sup>
3. On 25 September 2020, Mr Mustafa submitted to the Registrar, through the Head of the Defence Office, a request for the assignment of Mr von Bóné as Counsel and signed a Power of Attorney.<sup>3</sup>
4. Mr von Bóné is admitted to the List of Specialist Counsel in accordance with Rules 25(1) and 26(1) of the Rules and the Directive on Counsel.<sup>4</sup>
5. On 28 September 2020, the Registrar conditionally assigned Mr von Bóné as Counsel to Mr Mustafa in accordance with Sections 12 and 14(3) of the Directive on Counsel and Regulation 11 of the Legal Aid Regulations.<sup>5</sup>
6. This submission is filed as public, whereas Annex 1 is filed confidentially pursuant to Rule 82(1)(b) and (3) of the Rules, as it contains personal information about Mr Mustafa, namely his address and passport number, as well as personal information about Counsel, namely Counsel's contact details and passport number.
