## Order for a New Case File

**Specialist Prosecutor** Jack Smith **Duty Counsel for Hysni Gucati** Tamara Buruma

**Duty Counsel for Nasim Haradinaj** Bastiaan Martens **THE SINGLE JUDGE**,<sup>1</sup> pursuant to Article 33(2) of Law No. 05/L-53 on Specialist Chambers and Specialist Prosecutor's Office (the "Law"), hereby issues the following order.

1. Following the arrest and transfer of Hysni Gucati<sup>2</sup> and Nasim Haradinaj<sup>3</sup>, the Single Judge considers it necessary for the Registry to open a new Basic Court case file. Considering that the Specialist Prosecutor's request for arrest and transfer was filed for both suspects together, the specific offences alleged to have been committed by the two suspects correspond to a large extent, and the arrest took place on the same day, the Single Judge is of the view that one case file for both suspects may be opened carrying the case name "The Prosecutor v. Hysni Gucati and Nasim Haradinaj".

2. The present decision shall be the first document in the new case file. The documents listed below, including their annexes and corresponding translations, if available, shall be copied and transferred into the new case file and follow the present decision in chronological order. Unless ordered otherwise, these documents shall maintain their current classifications.

## DISPOSITION

- 3. For the above reasons, the Single Judge hereby:
  - a) ORDERS the Registry to open a new Basic Court case file with the case name "The Prosecutor v. Hysni Gucati and Nasim Haradinaj" and assign it a new case number;
  - b) **ORDERS** the Registry to file the present decision as the first document in the new case file;
  - c) **ORDERS** the Registry to subsequently copy and transfer the documents listed in paragraph 2 above, in chronological order, to the new case file; and
  - d) **ORDERS** the Registry to maintain, unless ordered otherwise, the classification level of each documents copied and transferred.
