Specialist Chambers ('Rules')1, when a person is arrested in Kosovo pursuant to an

arrest warrant issued by the Specialist Chambers, the competent authorities shall

promptly notify the Registrar, who shall immediately inform the President, the Panel,

and the Parties. The Registrar hereby informs of the arrest of Mr Nasim Haradinaj

('Mr Haradinaj') in Kosovo by the Specialist Prosecutor's Office ('SPO').

2. On 24 September 2020, the Single Judge issued a strictly confidential and ex parte

decision granting the SPO's request for an arrest warrant and transfer order ('Decision

on Arrest and Transfer').² In the Decision on Arrest and Transfer, the Single Judge

directed the SPO to serve and execute the arrest warrant in Kosovo.3

3. At approximately 16:10 on 25 September 2020, the SPO informed the Registrar

that Mr Haradinaj was arrested by the SPO in Kosovo on 25 September 2020.

4. The Registrar will submit a report to the Single Judge on the arrest and transfer

of Mr Haradinaj, pursuant to the Decision on Arrest and Transfer.⁴

5. This notification is submitted as strictly confidential and *ex parte* consistent with

the current classification of the Decision on Arrest and Transfer.
