Noting that, according to the Kosovo Liberation Army War Veterans Association's ("KLA WVA") own submissions, non-public and confidential documents relating to the work of the Special Investigative Task Force ("SITF"), the Specialist Prosecutor's Office ("SPO"), and/or the Specialist Chambers may be provided to the KLA WVA in the future;

Considering the accompanying serious risks to the integrity of the SPO investigations and Specialist Chambers' proceedings, as well as to the safety and security of potential witnesses and other persons;

Pursuant to Articles 39(3) and (11), 53(1), and 62(1) of the Law;

Order the KLA WVA, and any representative, member, or agent thereof to:

(a) immediately notify the SPO if it has in its possession or in the future obtains any documents which appear to be confidential or non-public and to relate to the work of the SITF, the SPO, or the Specialist Chambers; and (b) refrain from recording or copying, in whatever form, or disseminating, by whatever means of communication, such documents or their content, in the absence of authorisation of the SPO or the Single Judge;

Remind the KLA WVA, and any representative, member, or agent thereof, that pursuant to Article 53(1) of the Law, all entities and persons in Kosovo shall comply without undue delay with any order issued by the Specialist Chambers; and
