1. Pursuant to Rules 26(1) of the Rules¹, the Registrar hereby informs the Single Judge of the appointment of Counsel to Mr Hysni Gucati ('Mr Gucati').
2. On 25 September 2020, the Registrar assigned Ms Tamara Buruma as Duty Counsel to Mr Gucati.²
3. On 28 September 2020, Mr Gucati submitted to the Registrar, through the Head of the Defence Office, a request for the appointment of Mr Jonathan Rees as Counsel and signed a Power of Attorney.³
4. Mr Rees is admitted to the List of Specialist Counsel in accordance with Rules 25(1) and 26(1) of the Rules and the Directive on Counsel.⁴
5. On 28 September 2020, the Registrar appointed Mr Rees as Counsel to Mr Gucati in accordance with Sections 12 and 13 of the Directive on Counsel.⁵
6. On the same day, Mr Rees informed the Head of the Defence Office that he would like to be assisted by Mr Valon Hasani as Co-Counsel.⁶
7. Mr Hasani is admitted to the List of Specialist Counsel in accordance with Section 18 of the Directive on Counsel.⁷
8. On 28 September 2020, the Registrar approved Mr Hasani as Co-Counsel for Mr Gucati in accordance with Section 18 of the Directive on Counsel.⁸
9. This submission is filed as public, whereas Annex 1 is filed confidentially pursuant to Rule 82(1)(b) and (3) of the Rules, as it contains personal information about Mr Gucati, namely his address and passport number, as well as personal
