("Mr Haradinaj") is criminally responsible for the offences of intimidation during

criminal proceedings, retaliation and violating secrecy of proceedings, punishable

under Articles 387, 388 and 392 of the 2019 Criminal Code of Kosovo, No. 06/L-

074, by virtue of Article 15(2) of the Law;

HAVING FOUND that there are articulable grounds to believe that

Mr Haradinaj's arrest is necessary;

HAVING ISSUED an arrest warrant against Mr Haradinaj, born on 21 May 1963

in Gllogjan/Glođane, Deçan/Dečani, Kosovo, currently a Kosovan national,

Personal Number [REDACTED], with last known residence in [REDACTED],

Kosovo;

NOTING the decision of the President of the Specialist Chambers to relocate the

present proceedings to The Netherlands ("Host State");

PURSUANT TO Articles 3(8)(a), 39(3), 41(5) and (7), 53 and 55 of the Law,

Rules 50, 55(4) and (6) of the Rules of Procedure and Evidence Before the Kosovo

ORDER the Registrar to transmit the present transfer order to Kosovo, any relevant

accompanying officers as well as any and all possessions of the aforementioned

persons through border control and other checkpoints; (ii) accepting travel and

identification documents issued by the Host State or the Specialist Chambers; and

(iii) ensuring safety and security of any aircraft and/or other means of transportation

utilized for any such transfer and facilitating the unobstructed passage through

national border controls of its crew, if required;

AUTHORISE the Registrar to direct the competent Kosovo authorities to provide any

relevant details or information regarding the transfer of Mr Haradinaj to the Registrar,

recalling that, given the primacy of the Specialist Chambers over all other courts in

Kosovo, the Kosovo authorities shall comply with the present order, in accordance

with Article 53(2) and (3) of the Law, thus effectuating Mr Haradinaj's transfer; and

recalling that, should any entity, official of the Kosovo Government or any other

person in Kosovo obstruct the execution of the present order or violate any of its

conditions, this may constitute an offence pursuant to Article 15(2) of the Law;

AUTHORISE the Registrar to request the competent authorities of any relevant

(transiting) Third State, as the case may be, to provide their assistance for effectuating

the transfer of Mr Haradinaj, in accordance with Article 55 of the Law. In this regard,

should any technical or logistical difficulties or impediments arise in the execution of

this order, the competent state authorities are invited to raise such issues with the

representatives of the SPO and/or the Registry, as the case may be;

ORDER the Registrar to take all necessary measures to ensure operational security

and the security and safety of Mr Haradinaj and any accompanying court officers and

DECIDE that the present order, currently classified strictly confidential *ex parte*, may

be communicated, or its existence be revealed, to any competent authority of Kosovo,

a (transiting) Third State, as the case may be, and the Host State, as necessary for the

execution of the transfer order;

ORDER the SPO to transmit to the Registrar all available information that may be of

assistance in the execution of the transfer order as well as any information of relevance

to assessing any risks to victims and witnesses associated with the arrest and transfer

of the suspect; and

RECALL that pursuant to Articles 53(2) and 54 of the Law, the Specialist Chambers

have primacy over all other courts in Kosovo, and the present order has the same force

and effect as an order issued by any other Kosovo court or judge.
