Decision Setting the Date for the First Appearance of Hysni Gucati

**THE SINGLE JUDGE**,<sup>1</sup> pursuant to Articles 39(6) and 41(5) of the Law on Specialist Chambers and Specialist Prosecutor's Office ("Law") and Rule 55(6) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers ("Rules"), hereby renders this decision.

## I. PROCEDURAL BACKGROUND

- 1. On 22 September 2020, the Specialist Prosecutor's Office submitted a request for the issuance of an arrest warrant and corresponding transfer order against Hysni Gucati ("Mr Gucati").<sup>2</sup>
- 2. On 24 September 2020, the Single Judge issued the "Arrest Warrant for Hysni Gucati"<sup>3</sup> and the "Order for Transfer to Detention Facilities of the Specialist Chambers".<sup>4</sup>
- 3. On 25 September 2020, Mr Gucati was arrested<sup>5</sup> and transferred to the detention facilities of the Specialist Chambers in The Hague, the Netherlands.<sup>6</sup>

- 4. On 28 September 2020, the Registrar appointed Jonathan Elystan Rees ("Mr Rees") as Counsel for Mr Gucati in accordance with Sections 12 and 13 of the Directive on Counsel.<sup>7</sup>
- 5. On the same day, Mr Rees, Counsel for Mr Gucati, requested that the first appearance of Mr Gucati before the Single Judge take place on 1 October 2020 ("Request").8

## II. APPLICABLE LAW

- 6. Pursuant to Article 41(5) of the Law, a person deprived of liberty by or on behalf of the Specialist Chambers shall be transferred by way of travel specified in an order to the Specialist Chambers and brought before a Specialist Chambers Judge without delay.
- 7. Pursuant to Rule 55(6) of the Rules, any person arrested pursuant to an arrest warrant issued by the Specialist Chambers shall be brought without undue delay before a Panel, which shall satisfy itself that the person has been informed of the reasons for his or her arrest and of his or her rights under the Law and the Rules.
- 8. Pursuant to Article 39(6) of the Law, hearings, including the first appearance of a suspect, shall be public, unless the Specialist Chambers Judge decides otherwise in accordance with the Rules.

## III. DISCUSSION

9. Considering that the arrest of Mr Gucati and his transfer to the detention facilities of the Specialist Chambers took place on 25 September 2020, the Single Judge finds it appropriate to schedule a hearing for Mr Gucati's first appearance before him as soon as practicable, taking into account the constraints of COVID-19, with a view to ensuring that Mr Gucati's rights under the Law and the Rules are respected. The Single Judge also notes the Request of Mr Rees, Counsel for Mr Gucati, that the first appearance take place on 1 October 2020 and the fact that the Request was made with Mr Gucati's approval.<sup>9</sup>

10. Furthermore, noting that the publicity of hearings may extend beyond the courtroom, the Single Judge authorises the taking of photographs at the start of the hearing.

## IV. DISPOSITION

11. For the above-mentioned reasons, the Single Judge hereby:

- a) DECIDES to convene the hearing for the first appearance of Hysni Gucati before the Single Judge on Thursday, 1 October 2020, at 15:00 hours; and
- b) **AUTHORISES** the Registrar to organise at the start of the hearing the taking of photographs for one minute and a half.
