07/09/2020	Press Conference of the Association of KLA Veterans	<p>Hysni Gucati: "The association of KLA veterans has some news. Today, around 09:15 hrs, a package has arrived in the corridor of the office of the KLA veterans' association. We do not know who brought it. There are about 4,000 files of the Specialist Chambers in the package you are seeing now. Nasim is more informed about it as he has made some searches. He dealt with this material together with Faton and others. He will inform you about more details about this material and about what has happened from 09:15 hrs until now. What our association has said turns to be true. So, Nasim will inform you about everything in this material."</p> <p>Nasim Haradinaj: "First, we were little surprised, but it was a good surprise for us because it is being proved what our Government and MPs who have voted for this court are the most harmful people who hate Kosovo despite the fact they ask for our votes and say they are working for the interest of the country. Justifying and legitimizing a monoethnic court either by names of internationals as you will see they also have fallen prey of Serbia, especially of Milosevic apparatus, are continuing to harm Kosovo exactly with the state apparatus of Milosevic. 		<p>thousands of pages is that Clint Williamson has had direct ties with Vladimir VUCKOVIC [note: Serbian WCP] and Milovan DRACUN [note: Head of the Working Group] when help was demanded for creating this court. Then, David SCHWENDIMAN and his deputy Kwai Hong IP, have cooperated with these people and the deputy prosecutor of Serbia Dragoljub STANKOVIC and Ana MUTAVDZIC [head of WCPO]. And what is worse, here are the names of all witnesses for whom they claim they have protected. What is the reason for protecting the witnesses? For their own interests here is the data of Albanians, Roma, Serbs. The date and the place are mentioned here for any person who have been questioned. There are also statements. All these statements given under violence and pressure in the years 98-99 are required as a basis and to be verified once again. To verify it, the police chief in Prizren Sinisa TRAJKOVIC was summoned and then it is further stated that he now lives in Krusevac. He was a man of Milosevic who ordered rape, torture and murders in Prizren. The chief police of Mitrovica Radoljic Dragoljub [possibly Dragoljub RADELJIC] who according to these documents now lives in Kraleva was contacted. It is known what he did in Drenica region and Mitrovica and his missions in eradicating JASHARI family are known too. Here it is the chief of police in Pristina Trajkovic Nebojsa who</p>

		<p>now lives in Nis. They also contacted another person who now works in Nis court. It is about Bogdan Petric [possibly Bodan PERIC]. They have also cooperated with people of 'Civil Protection' of Milosevic era. It is about Radic Branislav who during that time was part of the 'Civil Protection' in Ferizaj. Now I want to say, which is the reason that our MPs including our President call on extension of the mandate of this court considering that its mandate has expired legally. KLA veterans association wants the crimes be resolved but these documents have proven they are acting selectively, they are acting with racism and they are cooperating with those people who were part of Milosevic apparatus and who have committed massacres on behalf of Milosevic but now they trying to act like heroes who want to resolve crimes, for Albanians as some Albanians are mentioned here and there also their names. We will submit these documents our Special Prosecution Office if it demands such a thing. We will send a copy also to our MPs so that their children be informed what their parents have voted for. I personally understand why Williamson David Schwendiman have resigned. I hope their conscience is killing them just like the case of the Dutch ambassador who said that "I knew that the court is making a mistake, but I was forced to vote for it". So, this proves that this court is completely politically motivated. The name of SALUSTRO was</p>

		<p>also mentioned in these documents but we have no time to deal with all this material. I hope that the media and all those who have dealt with this issue now will have more to deal with. I think the price should be paid by this court because saying it is confidential and leaking all the data, it is scandalous and a shameful act. And what is worse, it will harm the witnesses for whom it says they are protected. Considering that the data is published, it seems nothing is secret. All their data is here – the place where they were questioned, the date and the repetition of their statements. The people mentioned here have given their statements in places such as Jagodina, Vranje, Nis, Belgrade and not at the institutions of this court. That is all. I considered the public opinion should be informed and I want to say one more time that this material will serve the MPs to know what they have done. Also, the international community should know that they have fallen prey of the state apparatus of Milosevic and they should know that these people are still in the current government of Serbia. We may have made any mistake in dates, but we had no sufficient time to read all the material.”</p> <p>Question: Have you had any prior information on this?</p>

		<p>Nasim Haradinaj: “No, never. We have not received any prior notice. They only brought this package. And now we want to see the courage of our media, politicians, our court, and our international friends to tell us how this material was leaked. These documents are in English, and Serbian. There are statements in this material too. This material states the place, name, surname, the place they lived and the current place of living of the persons mentioned here, including phone numbers in some cases. We can say nothing more.”</p> <p>Question: “Can these documents be considered dangerous for witnesses.</p> <p>Nasim Haradinaj: Those who have allowed this material to be leaked should be aware of this. I said that how the safety of the witnesses may be guaranteed when their names may be read by anyone. We cannot be sure that the one who brought this material to us, will not distribute it on the streets. We can also do it. Why not to do it. Those who have accepted to protect the witnesses should be held accountable. I do not care about witnesses of the Hague court. As for me, I would publish the data of all the witnesses of this court. But those who have guaranteed the safety of these witnesses should deal with this issue. Maybe the court itself deliberately has published their names and information. I see this as a</p>

		<p>provocation of the court which leaked this material. I do not believe an ordinary person can deal with this material.”</p> <p>Question: Will you ask for abolishment of this court again?</p> <p>Nasim Haradinaj: “No. We will not ask any more for abolishment as the mandate of this court has already expired. We are against the President’s statement for extending its mandate. I believe that these MPs will not do such a thing, they will not repeat their mistake. We have previously demanded an amendment to the law but for the time being, we consider that this court is inexistent as its legal deadline has expired. It can be abolished by the Constitutional Court as its five-year mandate has expired.”</p>	
16/09/2020	Transcript of the press conference of head and deputy head of the KLA veterans’ Association, Hysni Gucati and Nasim Haradinaj	Hysni Gucati: Another surprise happened again today at KLA veterans’ association around 15:30 hrs. We have called this case ‘Lightning 2’ because the unknown person left like lightning. Two of our colleagues almost caught him but failed. We have also stated ten days ago that the Specialist Prosecutor’s Office and Specialist Chambers in the Hague cooperate mainly with Serbian prosecutors and the Special Court of Serbia on war crimes. 		<p>where the cooperation between Serb and Specialist Chambers prosecutors is seen. One of them is deputy prosecutor of the Special Court of Serbia Dragoljub Stankovic who has collected evidence that Albanians allegedly committed crimes and has submitted these documents to the Specialist Chambers. The second person is Milorad Delkovic, the general director of police in Serbia. He is member of 'MUP' in cooperation with the court prosecutors. I only present to you these two pages because we did not have much time to check all the files as they were brought at 15:30 hrs. These are statements and there are no names of any witnesses in these documents. Nasim has been dealing with these documents more than I. So, he can tell you more about this case.</p> <p>Nasim Haradinaj: This is absurdity that this happened by such a well-known international institution. How come they leaked this material. This court tried to insult our justice. They are not even at the level of our justice. We can see in these documents that there are over 57 communications between Clint Williamson and Vuckovic. Secondly, he has communication with the general director of the police Milorad Delkovic. Schwendiman has over 130 communications with Vuckovic, Dracun and others. Then, here we can see Kai who has over 37 communications with Dragoljub Stankovic, Drecun and others. These communications</p>

		<p>were all made about Drenica region, Llapashtica, Poklek, Radonic, Jabllanica, Klecka. So, there were communications about these places. This court is monoethnic and is cooperating with people who directly were part of Milosevic apparatus who committed crimes themselves.</p> <p>This Court has committed two atrocities, 1. It is a one ethnic court, 2. By calling for the files, it is collaborating with direct workers of the Milosevic apparatus, who themselves have committed crimes, burned and raped and receiving information from them now, they (the Court) are at the same time amnestying them (Serbs) and instead of bringing them to get investigated, it is accusing the Albanians. Therefore, this is the shame of the Court. We were insulted that we do not have courts, we are vulnerable, we are influential while these were directly influenced by Serbia on keeping their secrets and their flow.</p> <p>But I think that this is the result of the same police who the internationals brought here, who came here to show us the order but they never made an order for themselves, they never had a court and tried to divide us. That is why I am telling you once again, we have documents without names, we are not responsible for their flow. I see that words like "where did you get the documents," are circulating. Sir, information in the</p>

		<p>whole world can only be obtained in two ways: either stolen (or stolen by paying) or paid. This is how the information is obtained, but when it says it is a top secret and then comes to light, then do not mark it as a top secret.</p> <p>I only invite the media, to do as much as you are contributing, even if it is a stain, just try yourself here. I discussed with our lawyer and he told me: "None of the names you do not mention is punishable." I do not think the names of officials are a criminal offense and those who think of blackmailing by saying that we have the files, we know the names, they are anti-national people and people who do not love Kosovo.</p> <p>We know who the files were given to, we know where we sent them. I told you openly, the reason I am unprepared today, is just that someone should not speculate and misuse Nasim, for example, to say that I have the file and I know the names. For this reason, we did this in a hurry. For more, here you have the files, pick and choose or let and go.</p> <p>We put them here for whoever wants to take them, whether for Kosovo prosecution or for internationals, let them come and see where their materials are coming. Ours is to discredit the real reason of this Court, which is saying that it is strong and has accurate</p>

		<p>evidence. Now, no one is discrediting anyone more this court than herself by leaking flows and information. Whenever they bring us documents, we will publish them, and I will not hold any point in general.</p> <p>At least, it is our duty to show once again, to testify whether you are seeing which is the Court that was created for the protection of witnesses. They have started dealing once again with the cases of The Hague Tribunal, which is an even bigger court, they continue to deal with the indictments of Fatmir Limaj, Ramush Haradinaj and other people, even after the trial was processed once and received a verdict of innocence. This means that this Court is not what it was declared for and does not adhere to the principles and duties it has. All we can see is that this court is working for big money for a party or state interest, for Serbia. We don't know their connections or reasons.</p> <p>Hysni Gucati: Regarding the so-called 'Yellow House', we have documents, two persons that I have mentioned earlier denied the 'Yellow House'. The document is in Serbian language, dated 2014. So, they have been cooperating with the Serbia courts and prosecution prior to the establishment of the Specialist Chambers.</p> <p>Nasim Haradinaj: There is nothing neither for the Yellow House, nor for organ trafficking, even though</p>

		<p>the court was established based on these issues. So, the court was established for something else, while is dealing with other issues.</p> <p><i>Question: Do you have any idea, why these documents are brought to you?</i></p> <p>Nasim Haradinaj: Maybe because we dare to publish them and that we do not accept this court. I don't think we are the only one. I think you and your directors have them, too, but you are not publishing them. I am convinced that they brought these documents to you before they brought to us. Maybe this is just a prejudice, but I believe that he knew that we would publish them. You know that we are against this court. We are not against revealing the crimes, but against this racist, monoethnic and biased court.</p> <p><i>Question: However, how you would comment if there could be any murder, while you have just published the names...</i></p> <p>Nasim Haradinaj: I think you should be interrogated because you know that someone could be killed. We do not believe that someone will be killed. We have not published the names.</p> <p>Hysni Gucati: We did not mention the names.</p> <p><i>Question: You said that you have seen the person that brought the documents?</i></p> <p>Nasim Haradinaj: We ran after him, but he left. For me it is not a problem. I do not know why we ran after him. We welcome these documents. He even said that they will bring other documents again.</p>

		<p>Hysni Gucati: He (Haradinaj) ran after him, but he could not catch him. It is not the same person. He had completely different clothes and was taller. We call on Kosovo justice authorities to come and take the material. We don't have any problem at all.</p> <p>Nasim Haradinaj: Yesterday we saw a car following us, but we don't know why. None should survey on us, because we always speak out. We don't have anything to hide. Otherwise, if any of media are interested about the video from the CCTV we will send it to you through Whatsup. Cameras were not turned off, because they are always turned on.</p> <p><i>Question: How many files have you received?</i></p> <p>Hysni Gucati: There are three copies of approximately 800 pages.</p> <p>Nasim Haradinaj: The first files were classified, while the files we receive today were more mixed.</p>	
22/09/2020	Transcript of the press conference of head and deputy head of the KLA veterans' Association, Hysni Gucati and Nasim Haradinaj	<p>Head of Association of KLA Veterans, Hysni Gucati: Welcome, we already found a name for this man who is coming to our office – "The Flash 3" visited US again and was very fast like a flash he just popped out of the elevator dropped the files and went away through stairs. We have received new files at around 10:45, I do not know how many pages are because we had no time to count them. We believe new files have been leaked from the Special Court in the Hague. 		<p>we are not authorized to reveal them. We have stated earlier, and I want to reiterate again that it is good these files to be investigated by the local prosecution office as well as internationals to reveal who is bringing these files and are brought to us. We are now convinced one thing we are stating repeatedly. It is not good that this court is cooperating with the Serbian special prosecution. The new documents include names of various people and filing of the indictments are mentioned, and in these documents are mentioned that indictments are being prepared. [Showing the first page of documents to journalists] This is one of the documents, showing their minutes. We told earlier the special court investigators that we will publish all documents we receive, if they are not capable of preventing form being leaked. We want to tell the truth to the citizens of Kosovo that this court is trying by all means to 'lay bare' the KLA, but they will not succeed. It is in vain with all these falsifications they have made. I will not continue further; I will leave the floor to Nasim Haradinaj who will reveal details of the files.</p> <p><i>Nasim Haradinaj:</i> With my broken English I understood that these files are about a draft indictment against five potential indictees. Their names are mentioned: Azem Syla, Hashim Thaci, Jakup Krasniqi,</p>

		<p>Kadri Veseli and Rexhep Selimi. But in other files there are many mentioning of Xhavit Haliti and other people who were part of the war and ex-soldiers. What impressed me was the locations mentioned: Jabllanice, Likovc, Llapushnik, Drenoc, Malisheve, Bajice e Shales, Sedllar, llapashtica, Klecka, Zllashi, and other locations. You have all these files at your disposal. This time the man who brought the files was in a hurry and it seems that he brought only two copies. He left a message that from now on he would bring CDs, and no more files. We welcome him bringing CDs if he wants to, if not, nothing to worry. We bear no responsibility whatsoever and you journalists know your responsibilities too. We consulted the lawyer and he told us that in addition to the names already mentioned are other names, and charges against these people. The data of many people are mentioned here, the name of Naim Miftari and names of many other people. As of this moment these files are at your disposal. It is up to you to decide, you know the laws. We want to thank you for being active. I want to reiterate that our aim is not to cover-up crimes, if there is any crime, but it is our obligation is to defend our membership, not about their crimes, but for the reason that this court is established on foundation of slanderous statements, and based on the apparatus of Milosevic. All these charges are just a copy paste of the</p>

		<p>accusations of Milosevic and his system made earlier which have been refreshed to be presented in a new light. This is the opposite of what the European Parliament has voted for establishment of the court. As far as we know the Court has been established to deal with the slanderous statements of the so-called Yellow House. But maybe also our MPs were promised something in return of their votes. Now with these files they have a chance to see what they have voted for. The most important is that citizens of Kosovo cannot be deceived again and those who voted in favor of establishment of this court will have no chance to convince even their families to vote them again. To us statements of Hashim Thaci asking extension of the court's mandate and Ramush Haradinaj's call not to obstruct the work of the court are irrelevant statements. We are not defending any name be it Hashim Thaci or Ramush Haradinaj. We are defending members of the KLA Veterans Association. That is all.</p> <p><i>Q: Mr. Haradinaj you have stated that the unknown man bringing files told you that he will bring CDs. Will you publish them?</i></p> <p><i>Haradinaj:</i> Yes. Everything we receive in favor of rebutting filing of these indictments we will publish</p>

		<p>them. This is our position. Their bodies who came to collect the materials are aware of this. We expect them to come and we will save them a copy. But I want to explain again there are speculations that these files are not original. Of course, they are not, but are copies of the original documents.</p> <p><i>Q: You have stated that you represent Mr. Thaci and others?</i></p> <p><i>Haradinaj:</i> No! you are wrong. I did not say we represent someone in particular; we represent our membership. The individual names are irrelevant to us.</p> <p><i>Q: have you informed these people whose names you have just mentioned?</i></p> <p><i>Haradinaj:</i> No. This is why we call you to the press conference. You should inform them. We do not communicate with political representatives. We are the Organization of KLA Veterans which represents solely the war veterans. We count media to be as the fourth pillar of the state, but sometimes you are forgetting your mission. At least you should be that way, but you know it better. That is why we are submitting the files to you. We will not call anyone</p>

		<p>here are the files. We have journalists accusing us why you do not open a news portal. I do not want to open a news portal, because I am not journalist. But we should not trade blame on who is the most courageous, you just have to do your work, you are the fourth pillar of the state. I want to reiterate we are not defending any individual here, we are defending members of the KLA Veterans Association. We are not defending Hashim Thaci or any other politician, we are defending because the KLA is under attack. They are attacking the backbone of what everybody is enjoying today, including those who voted in favor of this court, and you for the free press, because you know how the press was beck then.</p> <p><i>Q: A question from Kallxo.com. Mr. Haradinaj, you have mentioned the draft indictment, what this document describes in more details?</i></p> <p><i>Haradinaj:</i> I am not entitled to describe in detail what is written in these documents. Here you are come and see the documents for yourself and explain their meaning. This is why I have invited you. The Parliament of Kosovo has started sessions. In two recent sessions MPs are not dealing with our proposal, and I use this opportunity to urge them. Please address our request because currently the Court is working</p>

		<p>without a mandate. But if they want extension of the mandate, they should consider our proposal to amend the Law and enable the court to prosecute all the crimes. The Association of KLA Veterans supports a court which would deal with all crimes regardless. We are not against solving crimes, because we know who committed the crimes who has the power to commit crimes, we know who committed genocide, rapes, and ethnic cleansing. And instead of facing indictments the same people today are perceived as hearos by giving their contribution on allegedly shedding light on crimes. This is the paradox which we have disagreed from the very beginning.</p> <p><i>Q: You did not give the documents that were brought to your office the second time, because they came very quickly ...</i></p> <p><i>Haradinaj:</i> This is a lie because the media took them that day, and the following day until we gave the document to them (Specialist Chambers). The KSC and SPO waited three hours until the lawyer arrived (at our offices). You are spreading a lie. They took 20% of papers. Journalists took as many (documents) as they wanted two days in a row.</p> <p><i>Q: (inaudible the part when the journalists asks Haradinaj if someone had asked the organization not to give the files)</i></p>

		<p>Haradinaj: They asked us to cooperate with them, but we did not listen to them. Also, you media have them because you have taken them from here.</p> <p><i>Q: Will you give these files to investigators if they come again for them?</i></p> <p><i>Haradinaj: We just want to confirm the authenticity, just as they did the other times so that there would be no speculations if they do or not (belong to Specialist Chambers). You can take a copy of them, as here are two copies. Take them, discuss them, but not misuse them. If they do not come to get them, the files will stay here 10 days. We would like our institutions to get these documents before them (Specialist Chambers). They told us that they will not come for these documents. They also emphasized that they are not a Kosovo court. So, also the Assembly of Kosovo has been lied to that it is a Kosovo court, the media, as well. Whoever was in the Netherlands could see that it does not have the sign "a Kosovo court". I was there too. They also said they would not come if we do not call them. However, we will not submit them without the presence of the lawyer. This is the least we can do. Even if they come now, we will not submit the files before the lawyer Tome Gashi arrives. There were speculations that we have changed the lawyer. We</i></p>

		<p>have not but our lawyer cannot deal with this case, and therefore we have hired Gashi.</p> <p><i>Q: You said that you tried to read the files in a 30-minute time. Why did not you call lawyer Gashi to see what these files contain?</i></p> <p>Haradinaj: You can tell your director what to do, but not us. Maybe we did not want to; or maybe we have called him. It is our business, not yours.</p> <p><i>Q: This is the third time that the “lightning” came (to your offices). Weren’t you afraid that he could also bring something else, that could endanger you?</i></p> <p>Haradinaj: We are not afraid of anyone. We welcome him. He promised to also bring CD. Then we will call him “flying saucer”. We have no security guards. We have asked the Specialist Chambers to provide security. I forgot to tell you that he brought the files in the KFOR presence. We were at a meeting with German KFOR, who saw these documents.</p> <p>Gucati: And we shoed KFOR the document page by page and they took photos of them.</p> <p>Haradinaj: We think that the people secure us. Now it is obvious that every KLA soldier is most attacked. We were ready to die at war, but if needed let them kill us now for peace. We have no security</p>

		<p>guards. You cannot come any time from 9 to 16. The door is open. People like him (who brought the files) are welcome. I will not tell about him even if I see him without a mask.</p> <p>Gucati: It is not our obligation. The judiciary should deal with him.</p> <p>Haradinaj: Today from the balcony we saw 5-6 persons around the office. And then he brought them (the files).</p> <p><i>Q: Did you inform the police when you saw them?</i></p> <p>Haradinaj: Why would we call the police? I am enjoying this. I feel like he is brining cakes. We are not concerned. If somebody wants to kill you, they can do so anywhere.</p> <p><i>Q: Could you find out what nationality that person belongs to?</i></p> <p>Haradinaj: He speaks Albanian.</p> <p>Gucati: He speaks Albanian. We do not know if he is English, German, American, or what but he speaks Albanian.</p> <p><i>Haradinaj:</i> There are internationals that speak Albanian better than the Albanians do. There is one thing I know for sure: that he is in the favor of Kosovo</p>

		<p>and the fighters. But you journalists are supposed to find out ...</p> <p><i>Q: You were at a meeting with German KFOR. Do you think that this was a game, that they knew you were at a meeting?</i></p> <p><i>Gucati:</i> It is a regular meeting that we hold every third month.</p> <p><i>Haradinaj:</i> Usually I held meetings as a spokesperson, so they were held more often. We also had irregular meetings, and Vetevendosje was interested to know where these files came from and how they came to our offices.</p> <p><i>Q: You are suggesting the media to publish these materials?</i></p> <p><i>Haradinaj:</i> Publish those that you can.</p> <p><i>Q: This is prohibited by law; it is punishable by up to ten years in prison.</i></p> <p><i>Haradinaj:</i> I do not know.</p> <p><i>Q: You are telling us to publish them, why aren't you publishing them yourself?</i></p> <p><i>Haradinaj:</i> Do you understand Albanian or not? Am I the fourth force, or are you?</p> <p><i>Q: But why are you not publishing them?</i></p>

		<p>Haradinaj: Because I do not want to, we are not the fourth force. If I were in the media, you would see if I would publish them.</p> <p><i>Q: We do not want to publish them.</i></p> <p>Haradinaj: If you do not dare, tighten up and do not speak. You do not tell me to publish them, you are the media, you have this job, you are the fourth force of the state. Give me your strength and you will see.</p> <p>Gucati: I wanted to answer here. You are the media that made public the fake veterans by name and surname, we were sorry at that time because the privacy of each person must be preserved but you published them by name and surname and now you are not able to you publish these files. You have the material in front of you, just as you made public the names of the fake veterans, take the same courage... If no one wants to add something, we would like to conclude this conference.</p>
