Decision on the Requests for Extension of the Time Limit for Filing Written Submissions

I. BACKGROUND TO THE PROCEEDINGS

1. The Panel refers to the background of the present proceedings as stated in its decision of 5 October 2020.¹ Further, the Panel recalls that, on 24 August 2020, the President of Kosovo proposed amendments to Article 162 of the Constitution of the Republic of Kosovo (the "Constitution"), which governs the Specialist Chambers and Specialist Prosecutor's Office (the "Proposed Amendment").²

II. REFERRAL

2. On 18 September 2020, the President of the Assembly of Kosovo conveyed the Proposed Amendment to the President of the Specialist Chambers pursuant to Articles 144(3) and 162(3) of the Constitution (the "Referral").³

3. In particular, the President of the Assembly of Kosovo requested the President of the Specialist Chambers to assign the Referral to the Specialist Chamber of the Constitutional Court for a review as to whether the Proposed Amendment does not diminish the rights and freedoms guaranteed by Chapter II of the Constitution.

4. On 22 September 2020, the President of the Specialist Chambers assigned the above Panel to decide on the Referral.⁴

III. NOTIFICATION AND REQUEST FOR INFORMATION

5. On 5 October 2020, the Panel decided to notify certain authorities of the Referral with a possibility for them to file, by 19 October 2020, written submissions, should they wish so to do, on the admissibility and/or merits of the Referral. These authorities

included also the High Representative of the Union for Foreign Affairs and Security Policy/Vice-President of the European Commission (the "High Representative") and Head of the European Union Rule of Law Mission in Kosovo (EULEX Kosovo). The Panel also requested the President of Kosovo to submit certain information to the Panel.⁵

IV. REQUESTS FOR EXTENSION OF THE TIME LIMIT

6. On 19 October 2020, the High Representative⁶ and Head of EULEX Kosovo⁷ requested the Panel to extend to 2 November 2020 the time limit for filing written submissions on the admissibility and/or merits of the Referral. They referred to the need to duly examine the Referral and the required internal procedures.

7. With regard to these requests, the Panel recalls that, pursuant to Rule 15(2) of the Rules of Procedure for the Specialist Chamber of the Constitutional Court (the "Rules"), the Panel may request additional information or submissions, as deemed necessary, in relation to the Referral. Further, it follows from Rule 15(3) of the Rules that submissions directed by the Panel shall be filed within the time limits set by the Panel.

8. In view of the reasons stated in the requests of the High Representative and Head of EULEX Kosovo respectively for extension of the time limit (see paragraph 6 above), the Panel finds it appropriate to grant these requests and thus extend to 2 November 2020 the time limit for filing written submissions on the admissibility and/or merits of the Referral.

FOR THESE REASONS, THE CONSTITUTIONAL COURT PANEL

1. *Grants* the requests of the High Representative and Head of EULEX Kosovo for extension of the time limit for filing written submissions on the admissibility and/or merits of the Referral, and *extends* this time limit for the High Representative and Head of EULEX Kosovo to 2 November 2020.

2. *Directs* that the written submissions should not exceed 10 pages.
