 Pursuant to Rule 26(1) of the Rules<sup>1</sup>, the Registrar hereby informs the Pre-Trial Judge of the appointment of Mr David Young as Counsel to Mr Rexhep Selimi.

2. On 5 November 2020, the Registrar assigned Mr Robert Kaarls as Duty Counsel to Mr Selimi pending the appointment or assignment of Counsel.<sup>2</sup>

3. At the initial appearance of Mr Selimi on 11 November 2020, Mr Kaarls informed the Pre-Trial Judge that Mr Selimi would be requesting the appointment of Mr Young as Counsel, and the Pre-Trial Judge requested the Registrar to make a filing in the case informing the Pre-Trial Judge of her decision thereon.<sup>3</sup>

4. On 12 November 2020, Mr Selimi submitted to the Registrar, through the Head of the Defence Office, a request for the appointment of Mr Young as Counsel, as well as a Power of Attorney authorising Mr Young to represent him before the Specialist Chambers.<sup>4</sup>

Mr Young is admitted to the List of Specialist Counsel in accordance with Rules
25(1) and 26(1) of the Rules and the Directive on Counsel.<sup>5</sup>

6. On 12 November 2020, the Registrar appointed Mr Young as Counsel to Mr Selimi in accordance with Sections 12 and 13 of the Directive on Counsel.<sup>6</sup>
