- 1. On 25 April 2020, the Specialist Prosecutor's Office ('SPO') requested that the Pre-Trial Judge confirm an indictment against Hashim THAÇI, Kadri VESELI, Rexhep SELIMI, and Jakup KRASNIQI ('Suspects'). At that time, the SPO also foreshadowed filing a future request concerning arrest warrants and associated relief ('Request').
- 2. Pursuant to Article 36(1) of the Practice Direction,³ the SPO requests that the Pre-Trial Judge authorise a limit of 9,000 words for the Request.⁴ In the present, exceptional circumstances, good cause exists for this extension in light of the complex factual and legal circumstances involved by the Request and the accompanying need for the SPO to make meaningful submissions in full conformity with the relevant provisions of the Law⁵ and Rules.⁶ In this regard, the SPO intends to make submissions on and request multiple reliefs relating to the arrest and transfer of the four Suspects, search and seizure, [REDACTED], and non-disclosure of the Indictment and related material.
- 3. This filing is filed strictly confidential and *ex parte* in accordance with Rules 85(4) and 86(2).
