- 1. The Specialist Prosecutor's Office ('SPO') hereby files:
 - a Corrected Confirmed Indictment¹ and Corrected Redacted Indictment,² correcting certain clerical errors in previous versions thereof,³ and
 - (ii) pursuant to Rule 82(2) of the Rules⁴ and in accordance with the Decision,⁵ a Public Redacted Indictment.⁶

2. Considering the very limited and clerical nature of the corrections and to avoid any unnecessary complication of imminent, planned arrest and transfer operations, the SPO requests that the Corrected Redacted Indictment not be served on the Accused until after the transfer of all four Accused to the Detention Facility of the Specialist Chambers in The Hague.⁷

3. Further, the SPO requests reclassification of the Public Redacted Indictment as public upon confirmation of transfer of all four Accused to the Detention Facility of the Specialist Chambers in The Hague.

- (i) in respect of the documents relating to a particular Accused, upon confirmation of the transfer of that Accused to the Detention Facility of the Specialist Chambers in The Hague with redactions to: (i) the identities of any Accused who have not yet at that time been transferred to the Detention Facilities in The Hague; (ii) personal data of the particular Accused (i.e. the PIN and address(es)); and (iii) the Statement of Crimes section in the Arrest Warrant;¹² and/or
- (ii) upon confirmation of the transfer of all four Accused to the Detention Facility of the Specialist Chambers in The Hague with redactions to: (i) personal data of each of the Accused; and (ii) the information specified at paragraph 4 above.
