THE PRE-TRIAL JUDGE,¹ pursuant to Article 39(2) and (3) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office ("Law") and Rules 85(5) and 86(3) and (4)(a) of Rules of Procedure and Evidence Before the Kosovo

Specialist Chamber ("Rules"), hereby issues the following decision.

I. PROCEDURAL BACKGROUND

1. On 24 April 2020, the Specialist Prosecutor's Office ("SPO") submitted for

confirmation a strictly confidential and ex parte indictment ("Indictment") together

with evidentiary material supporting the material facts underpinning the charges and

a detailed outline demonstrating the relevance of each item of evidentiary material to

each allegation.2

2. On 17 June 2020, the Pre-Trial Judge permitted the SPO to present additional

supporting material to the Indictment.³

3. On 24 July 2020, upon order of the Pre-Trial Judge,⁴ the SPO submitted a revised

indictment ("Revised Indictment").5

4. On 29 July 2020, the SPO requested permission to submit additional supporting

material to the Revised Indictment ("Request").6 This material includes the statement

of a suspect subject to the Revised Indictment conducted between 13 and 16 July 2020,7

and other documents used during the suspect's interview that have not yet been

submitted8 (collectively, "Additional Supporting Material"). The SPO submits that the Additional Supporting Material only recently became available, is of limited scope and length, and is relevant to the charges in the Revised Indictment.9

II. APPLICABLE LAW

5. Article 39(2) of the Law provides that the Pre-Trial Judge shall review the indictment and, pursuant to Rule 85(5) of the Rules, render a decision on that review no later than six months from the filing of the indictment and all supporting material.

6. Pursuant to Rule 86(3) of the Rules, the indictment shall be filed together with supporting material which shall include a detailed outline demonstrating the relevance of each item of evidentiary material to each allegation.

7. Pursuant to Rule 86(4)(a) of the Rules, the Pre-Trial Judge may permit the Specialist Prosecutor to present additional material in support of any or all charges.

III. DISCUSSION

8. When deciding to permit the SPO to present additional material for a second

time, the Pre-Trial Judge must notably ensure that the entire review of the

indictment process is completed within the time frame set out in Rule 85(5) of the

Rules.

9. Despite the fact that the Request is filed more than three months after the

Indictment, the Pre-Trial Judge considers that, in the present circumstances, the

Request is timely, considering that the interview of said suspect was conducted

only two weeks ago. Despite the noticeable length of the Additional Supporting

Material,10 the Request will not jeopardise the six month timeframe set out in

Rule 85(5) of the Rules for the rendering of a decision on the review of the Revised

Indictment.

10. The Pre-Trial Judge further notes that the Additional Supporting Material

presented consists of the suspect's statement and documents discussed during his

recent interview, which are prima facie relevant to the charges pleaded in the

Revised Indictment.

11. In light of the foregoing, the Pre-Trial Judge permits the SPO to submit the

Additional Supporting Material.

12. Furthermore, and as a consequence of the above, the Pre-Trial Judge orders

the SPO to prepare a supplement to the Rule 86(3)(b) outline already submitted,

demonstrating the relevance of the Additional Supporting Material to each factual

allegation that fulfils the relevant legal requirement(s) of the crime(s), including

the contextual elements, and/or mode(s) of liability, as the case may be.11
