## I. INTRODUCTION

1. Pursuant to Article 36(1) of the Practice Direction,<sup>1</sup> the defence for Mr Hashim Thaçi ("the defence") requests an extension of the word limit in order to authorize the filing of an application for interim release of 8500 words. The defence submits that the exceptional circumstances justifying such an extension are constituted by the importance of the subject matter of the application and the volume of material which requires to be addressed therein.

The present application is filed as confidential because it refers to confidential filings and disclosure but the defence has no objection to its reclassification as public.

## II. SUBMISSIONS

3. An application for interim release pending trial is one of the most important filings a defence team will make. Given the issue at stake, the liberty of the accused, such a request requires to be detailed and properly reasoned, both legally and factually.

4. In the present case, the arguments made by the Specialist Prosecutor's Office ("SPO") in seeking Mr Thaçi's arrest and detention are extensive and the material relied on is voluminous. While the SPO initial substantive request itself extends to 6,690 words,<sup>2</sup> above the 6,000-word limit,<sup>3</sup> the material relied on is provided in three annexes and in the SPO disclosure package 7, containing 35 documents

(reports, judgements, witnesses statements, etc.) notified on 20 November 2020. In addition, the issues raised, such as the alleged risk of flight and witness interferences, have been addressed subsequently in several other filings to which the defence may reply.<sup>4</sup>

5. In order to address properly the SPO's arguments and supporting material, the defence requires an extension of the 6,000-word limit.

## III. CONCLUSION

6. For the forgoing reasons, the defence requests the Pre-Trial Judge to:

**AUTHORISE** the above requested extension of the word limit in respect of the application for interim release to be filed by the defence.
