- 1. Pursuant to Rule 26(1) of the Rules,<sup>1</sup> the Registrar hereby informs the Pre-Trial Judge of the appointment of Mr Bastiaan Dirk Willem Martens ('Mr Martens') as Counsel to Mr Nasim Haradinaj ('Mr Haradinaj').
- 2. Pursuant to Section 17(2) of the Directive on Counsel, the Registrar shall *assign* Duty Counsel in urgent matters and for a limited period pursuant to the Legal Aid Regulations.<sup>2</sup> Pursuant to Section 12(1)(a) and Section 13 of the Directive on Counsel, the Registrar shall *appoint* chosen Counsel to a suspect or Accused who has sufficient means to retain Counsel.
- 3. On 25 September 2020, the Registrar assigned Mr Martens as Duty Counsel to Mr Haradinaj pending the appointment or assignment of Counsel in accordance with Section 12 of the Directive on Counsel.<sup>3</sup>
- 4. On 30 November 2020, Mr Haradinaj requested the appointment of Mr Martens as Counsel and signed a Power of Attorney.<sup>4</sup> Mr Martens is admitted to the List of Specialist Counsel in accordance with Sections 7 and 13(2) of the Directive on Counsel.<sup>5</sup>
- 5. That same day, the Registrar appointed Mr Martens as Counsel in accordance with Sections 12 and 13 of the Directive on Counsel. <sup>6</sup>
