1. The SPO submits this report pursuant to decisions authorizing the seizure of material issued by the Single Judge on 7 September 2020<sup>1</sup> and 17 September 2020<sup>2</sup> (collectively, the 'Decisions'). In the Decisions, the Single Judge ordered<sup>3</sup> the SPO to review the relevance of the seized material within four-months from the execution of the requested seizure and to retain, return or destroy the seized material as prescribed by Rule 33 of the Rules.<sup>4</sup>
2. The SPO has reviewed the relevance of the material seized, and has determined that such material is of continued relevance to ongoing SPO investigations and to future proceedings. Accordingly, the SPO will retain the material.
3. Pursuant to Rule 82(4), these submissions are classified as 'Public'.
