





He visited his *Oda* /traditional men's reception room/ but how did Sylejman SELIMI refuse President THAÇI's decoration/?/



Tonight he visited his /Hashim THAÇI's/ reception room in Buroja of Skënderaj, however, the former KLA General commander did not have the same opinion and disposition for president THAÇI on 19 February last year.

SELIMI refused president THAÇI's decoration by saying that he did it in order not to be a hypocrite.

He said that he could not accept the decoration for his contribution in the KLA following his statement that he was being held "unjustly in prison for alleged war crimes".

"I had the honour to receive decorations and gratitude by different domestic and international personalities, Kosovo presidents, Albania presidents, also by international personalities, including NATO Secretary General, NATO admirals and generals, many KFOR generals, Kosovo chief administrator, Iowa State Guard Commander – USA, US Ambassador and many other domestic and international personalities. I was proud that my contribution and work in the service of the country was being honoured every time I received a decoration or was honoured with gratitude. I read in the media today that my name was amongst many people decorated by Kosovo's President on the occasion of the 10th Anniversary of independence. How can I receive a decoration for merits in war at a time I am being held unjustly in prison for alleged war crimes? That is why such a decoration is unacceptable for me, for as long as I am unjustly being held and convicted. I refuse this

decoration thus, I do not have to feel guilty of hypocrisy," said SELIMI's letter written on 19 February 2018 refusing president THAÇI's decoration.

However, tonight he visited president THAÇI's *oda* in Buroja village, Skënderaj, together with Assembly speaker Kadri VESELI and former Skënderaj /Municipality/ leader Sami LUSHTAKU.

Former TMK /Kosovo Protection Corps/ Commander and former Kosovo Ambassador to Tirana /Albania/, Sylejman SELIMI, was released yesterday from prison. He will be under the supervision of the Kosovo Probation Service until 30.10.2020.

SELIMI was arrested in May 2013 and was found guilty of the criminal offence of war crimes against the civilian population by the Mitrovica Basic Court on 27 May 2015. He received a 6-year prison term.

On 7 June 2018 there was a retrial in the "Drenica 2" /case/ and "Drenica 1" /case/ on 11 June. In relation to this case his Counsel Tomë GASHI said several days ago that Sylejman SELIMI continued to be held in prison for three months without any legal right.

During his imprisonment SELIMI was transferred several times to Kosovo University Clinical Centre (QKUK). He suffered from several illnesses.

He was also hospitalised 19 days ago, several days after the report that he was among dozens of people summonsed by the Specialist Prosecution Office in the Hague.

It is not yet known when will SELIMI travel to the Hague to be interviewed by the Specialist Prosecution office. /Insajderi.com
