Counsel for Jakup Krasniqi: Venkateswari Alagendra THE PRESIDENT of the Specialist Chambers ("President"), acting pursuant to Articles 33(1)(c), 41(10) and 45(2) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office, Rules 58, 169 and 170 of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers and Rules 3 and 4 of the Rules on Assignment of Specialist Chambers Judges from the Roster of International Judges ("Rules on Assignment"), herewith assigns a Court of Appeals Panel to decide on interlocutory appeals filed by Messrs Hashim Thaçi, Kadri Veseli, Rexhep Selimi and Jakub Krasniqi ("Accused") against decisions issued by the Pre-Trial Judge rejecting their requests for interim release (collectively "Appeals").¹

I. PROCEDURAL BACKGROUND

1. On 4 November 2020, Mr Krasniqi was arrested in Kosovo pursuant to an arrest warrant issued by the Pre-Trial Judge on 26 October 2020² and was transferred to the Detention Facilities of the Kosovo Specialist Chambers in The Hague on the same day.³

2. On 5 November 2020, Messrs Thaçi, Veseli and Selimi were arrested in Kosovo pursuant to arrest warrants issued by the Pre-Trial Judge on 26 October 2020⁴ and were transferred to the Detention Facilities of the Kosovo Specialist Chambers in The

Hague on the same day.⁵

3. On 22 January 2021, the Pre-Trial Judge denied the requests for interim release of the Accused ("Impugned Decisions").⁶

4. On 1 February 2021, Mr Veseli appealed the Impugned Decision.⁷

5. On 3 February, Messrs Thaçi, Selimi and Krasniqi appealed the Impugned Decisions.⁸

II. ASSIGNMENT

6. Having considered the criteria set forth in Rule 4(2) of the Rules on Assignment, including relevant experience and expertise as well as availability at this time,
