**THE PRE-TRIAL JUDGE**,¹ pursuant to Article 39(13) of the Law on Specialist Chambers and Specialist Prosecutor's Office and Rule 96(1) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers, hereby renders this order.

- 1. On 3 February 2021, the Pre-Trial Judge decided to convene a status conference ("Third Status Conference") in the presence of the Specialist Prosecutor's Office ("SPO") and the Defence on Thursday, 11 February 2021, at 11:00h ("Order").
- 2. For organisational reasons, and having considered the availability of the Parties, the Pre-Trial Judge hereby decides to reschedule the Third Status Conference to Tuesday, 16 February 2021, at 11:00h.
- 3. During the hearing, the Pre-Trial Judge will ask the Parties for updates, if any, on the matters set out in the Order.<sup>3</sup> The Pre-Trial Judge notes that the SPO<sup>4</sup> and the Registry<sup>5</sup> have filed their respective submissions on these matters by the deadline set out in the Order.<sup>6</sup> The deadline for the Defence to provide written submissions, if they so wish, on any of these matters and/or any additional matters shall remain Wednesday, 10 February 2021, at 12:00 hours.<sup>7</sup>
