1. On 15 February 2021 the Specialist Prosecutor's Office ('SPO') filed the Pre-Trial Brief together with Witness and Exhibit Lists,<sup>1</sup> followed by confidential redacted versions of these documents filed on 17 February.<sup>2</sup>
2. Certain errors in the format of the Evidence Registration Number ('ERN') of documents cited to in footnotes of the Pre-Trial Brief have been identified. In particular, certain footnotes need correction to reflect the specific format in which the ERNs appear in Legal Work Flow ('LWF').<sup>3</sup> Further, three references (whose ERNs were duplicates of documents already cited) were removed as incorrectly cited.<sup>4</sup>
3. These corrections do not affect the substance of the brief, but are necessary to more readily facilitating location of the relevant underlying documents in LWF.
4. As a result of these corrections, the SPO hereby files corrected versions of:
  - a. the Pre-Trial Brief;<sup>5</sup> and
  - b. the Confidential Redacted Version of the Pre-Trial Brief.<sup>6</sup>
