- 1. The Specialist Prosecutor's Office ('SPO') hereby files:
 - (i) A strictly confidential, lesser redacted version of the Confirmed Indictment for service on the Accused, upon his transfer to the Detention Facility of the Specialist Chambers in The Hague;¹ and
