I write this memorandum to inform you that the Registry has fully implemented the instructions contained in the "Decision on Categorisation of Evidence Under Rule 109(c) and Related Matters", dated 12 March 2021 ("Decision"),<sup>1</sup> and to provide an update on the steps the Registry has undertaken following the issuance of the aforementioned Decision.

In the Decision, the Pre-Trial Judge adopted case-specific categorisation and *inter alia* ordered [...] "the SPO to provide the Court Management Unit with the necessary details regarding the case-

*specific categorisation”<sup>2</sup> and directed “the Court Management Unit to amend, as soon as possible, the Legal Workflow in order to reflect the case-specific categorisation, as adopted.”<sup>3</sup>*

- *On 30 March 2021, the Specialist Prosecutor’s Office (‘SPO’) provided to the Court Management Unit (‘CMU’) the relevant information as indicated in para.27(b) of the Decision.*

In order to ensure accurate mapping and alignment of the new (additional) meta data to the existing categories, CMU with the Information Technology Services Unit continued to consult with the SPO to ensure that the integrity of the already disclosed records in the Kosovo Specialist Chambers Legal Workflow was intact.

- *On Tuesday, 13 April 2021 at 17:30 CET the Kosovo Specialist Chambers Legal Workflow was updated and the amendments became available.*
- *On Wednesday, 14 April 2021 at 12:23 CET all the Kosovo Specialist Chambers Legal Workflow users in File Number: KSC-BC-2020-06 were informed through eMail that amendments were implemented.*
- *On Thursday, 15 April 2021 at 12:35 CET, CMU issued and distributed a revised version of the Kosovo Specialist Chambers Legal Workflow User Guide. This updated version includes amongst other general updates a section specifically dedicated to sub-categories.*

In addition to the user guide, in the days ahead CMU shall conduct trainings for the Kosovo Specialist Chambers Legal Workflow users in File Number: KSC-BC-2020-06, enabling them (as applicable) to add and/ or search for the (sub) categorisation of materials disclosed under Rule 109(c) of the Rules of Procedure and Evidence.
