1. Pursuant to Detention Rule 10.2 of the Rules of Detention,<sup>1</sup> promptly upon reception of a Detainee at the Detention Facilities of the Specialist Chambers, the Chief Detention Officer shall notify the Registrar, who shall transmit the notification of reception to the relevant judicial authorities and inform the relevant parties and persons, including the Head of the Defence Office.

2. The Registrar hereby transmits the annexed notification of reception of Mr Pjetër Shala ('Mr Shala') in the Detention Facilities of the Specialist Chambers in The Hague, the Netherlands.<sup>2</sup> The Registrar has also transmitted the notification of reception to the Head of the Defence Office.

3. Pursuant to Rule 26(1) of the Rules,<sup>3</sup> the Registrar further informs the Pre-Trial Judge of the conditional assignment of Mr Jean-Louis Gilissen ('Mr Gilissen') as Counsel to Mr Shala and of the approval of Mr Hédi Aouini ('Mr Aouini') as Co-Counsel.

4. On 19 March 2021, pending Mr Shala's possible transfer to the custody of the Specialist Chambers, Mr Gilissen submitted to the Registrar, through the Defence Office, [REDACTED] a corresponding request by Mr Shala for the assignment of Mr Gilissen as Counsel, together with a Power of Attorney.<sup>4</sup> Mr Gilissen is admitted to the List of Counsel pursuant to Section 7(3) of the Directive on Counsel.<sup>5</sup> Pending [REDACTED], the Registrar conditionally assigned Mr Gilissen as Counsel to Mr Shala on 15 April 2021.<sup>6</sup>

5. On 12 April 2021, Mr Gilissen submitted to the Registrar, through the Defence Office, a request for the approval of Mr Aouini as Co-Counsel. Mr Aouini is

conditionally admitted to the List of Counsel pursuant to Section 7(2) of the Directive on Counsel.<sup>7</sup> The Registrar conditionally approved Mr Aouini as Co-Counsel for Mr Shala on 15 April 2021, pending a final decision on the admission of Mr Aouini to the List of Counsel and the submission of Mr Aouini's contract with Counsel.<sup>8</sup>
