I. INTRODUCTION

1. The Defence for Jakup Krasniqi ("Defence") hereby join the Veseli Defence Request for Word Limit Variation, filed on 3 May 2021.¹ Considering the length and complexity of two of the responses filed by the Specialist Prosecutor's Office ("SPO") to the Defence's preliminary motions, namely the Consolidated Prosecution Response to Thaçi, Selimi, and Krasniqi Preliminary Motions on the Form of the Indictment, KSC-BC-2020-06/F00258,² and the Consolidated Prosecution Response to Preliminary Motions Challenging Joint Criminal Enterprise (JCE), KSC-BC-2020-06/F00263,³ the Defence support the request for a variation of word limit.

II. SUBMISSIONS

2. The Defence note that following a request submitted by the SPO,⁴ a substantial extension of the usual word limit⁵ was granted for the Consolidated Prosecution Response to Preliminary Motions Challenging Joint Criminal Enterprise (JCE), specifically an extension up to 24,000 words.⁶ As submitted by the Veseli Defence, the SPO's response spans 67 pages in length and over 23,800 words. Further, the Consolidated Prosecution Response to Thaçi, Selimi, and Krasniqi Preliminary Motions on the Form of the Indictment amounts to 27 pages and 8,963 words. In light of the length and complexity of the SPO's responses, the Defence submit that the usual

word limit accorded for a reply⁷ would not suffice and that a request for word limit variation is appropriate.

 - a. grant an extension of 4,000 words for its reply to SPO response KSC-BC-2020-06/F00258;
 - b. grant an extension of 4,000 words for its reply to SPO response KSC-BC-2020-06/F00263.
