1. Pursuant to the Status Conference Order,<sup>1</sup> the Specialist Prosecutor's Office ('SPO') hereby provides written submissions on the proposed redactions to be applied to the Confirmation Decision,<sup>2</sup> in order to make it available to the Defence and the public.

- 2. In order to make the Confirmation Decision available to the Defence and the public, redactions to the names and identifying information of any victim or witness described in the Confirmation Decision should be redacted. These redactions would be similar to those already authorised on a provisional basis by way of the Confirmation Decision.<sup>3</sup>
- 3. The circumstances set out in the SPO's Initial Submission of Indictment are still applicable.<sup>4</sup> There are real risks of interference with witnesses and victims, which, pursuant to Rule 105, constitute exceptional circumstances justifying interim non-disclosure of the identities of witnesses and victims involved in these proceedings until appropriate protective measures have been ordered. Accordingly, the proposed redactions to be applied to the Confirmation Decision at this stage are necessary to ensure the integrity of the proceedings, and the protection of witnesses and victims.
- 4. In addition, and as a precautionary measure, the SPO requests redaction of certain ERNs, including transcript numbers, from the any public version of the Confirmation Decision. This measure is necessary pending completion of the ongoing exercise of cross-checking against, and potentially making adjustments as a result of, confidential material [REDACTED].
- 5. In Annex 1, redactions requested for any confidential redacted version of the Confirmation Decision are identified by way of red boxes surrounding the relevant text. In any public redacted version of the Confirmation Decision, the SPO respectfully
