- 1. Pursuant to the Order,¹ the Specialist Prosecutor's Office ('SPO') hereby provides submissions related to the reclassification of certain filings.
- 2. The SPO has no objection to the reclassification of filing F00012 as public.<sup>2</sup> In relation to F00019 (main filing), the SPO recalls the reasons for confidential classification.<sup>3</sup> However, considering the Order,<sup>4</sup> the SPO does not oppose reclassification of F00019 (main filing) as public, provided the Defence does not object.
- 3. Further, pursuant to the Order,<sup>5</sup> the SPO has filed: (i) public redacted versions of filings F00026, F00027 (main filing), and F00086/A01; and (ii) a confidential redacted version of F00026. The redactions to these filings are necessary to protect witnesses and victims, personal data of the Accused, and/or the confidentiality and integrity of investigations and proceedings.<sup>6</sup>
- 4. On 5 May 2021, the SPO provided the Defence its comments concerning the filing of a public redacted version of F00108/A01.<sup>7</sup>
