1. Pursuant to Article 22(5) of the Law,¹ Rules 26(2) and 113(7) of the Rules,² and the First Decision on Victims' Participation ('First Decision'),³ the Registrar hereby notifies the Pre-Trial Judge of the assignment of Victims' Counsel for the purposes of the common representation of Group 1 of victims participating in the proceedings ('VPPs').

I. PROCEDURAL HISTORY

- 2. On 4 January 2021, the Pre-Trial Judge issued a Framework Decision on Victims' Applications.⁴ As per the Pre-Trial Judge's instructions, the Victims' Participation Office ('VPO') submitted its First Report on received applications on 15 February 2021,⁵ which was supplemented on 1 April 2021.⁶
- 3. On 21 April 2021, the Pre-Trial Judge issued the First Decision granting the applications of Victims 01/06, 02/06, 03/06, 04/06, 07/06, 16/06, 17/06, 18/06 and 19/06 and admitting them to the proceedings as VPPs.⁷ The Pre-Trial Judge further decided that those nine VPPs shall be represented as Group 1 and directed the Registrar to assign, by Friday, 7 May 2021, a Victims' Counsel for the purpose of their common representation.⁸

II. APPLICABLE LAW

4. Article 22(5) of the Law provides that victim groups shall be assisted and represented by a Victims' Counsel. Pursuant to Rules 26(2) and 113(7) of the Rules,

after the VPPs have been consulted and their interests and views taken into account, the Registrar shall assign a Victims' Counsel from the List of Victims' Counsel to a group of VPPs in accordance with the Directive on Counsel and the Legal Aid Regulations.⁹

5. In assigning Victims' Counsel, the Registrar shall, in accordance with the procedure laid down in the Legal Aid Regulations, take into account: (i) the proposal of the Head of the VPO; (ii) consultations with the VPPs who expressed their views and interests; and (iii) considerations of a potential conflict of interest and other relevant circumstances. ¹⁰ Before making a proposal to the Registrar, the Head of VPO shall consult with the Independent Representative Body of Specialist Counsel. ¹¹

III. SUBMISSIONS

- 6. On 7 May 2021, the Registrar assigned Mr Simon Laws ('Mr Laws') as Victims' Counsel to Group 1 of VPPs in accordance with Sections 12(2) and 15 of the Directive on Counsel and Regulation 31 of the Legal Aid Regulations.¹²
- 7. Mr Laws was admitted to the List of Victims' Counsel on 30 October 2020 in accordance with Rules 25(1) of the Rules and Section 7(3) of the Directive on Counsel.
