THE PRE-TRIAL JUDGE,¹ pursuant to Rule 98(1) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers ("Rules"), hereby issues this decision.

I. PROCEDURAL BACKGROUND

- 1. On 12 June 2020, the Pre-Trial Judge confirmed an indictment against Salih Mustafa ("Mr Mustafa").²
- 1. On 24 September 2020, Mr Mustafa was arrested pursuant to a decision³ and an arrest warrant issued by the Pre-Trial Judge.⁴
- 2. On 5 March 2021, the Pre-Trial Judge informed the Parties that the transmission of the case file to the Trial Panel is anticipated to take place on or around Friday, 7 May 2021, subject to the resolution of any outstanding matters.⁵
- 3. On 5 May 2021, the Pre-Trial Judge notified the President of the Specialist Chambers ("President") that a complete case file in accordance with Rule 98 of the Rules would be ready for transmission on Friday, 7 May 2021.6
- 4. On 5 May 2021, the President assigned Judges Roland Dekkers, Mappie Veldt-Foglia, Gilbert Bitti, and Vladimir Mikula (reserve) to Trial Panel I.⁷

5. On 7 May 2021, pursuant to Sections 12(2) and 15 of the Directive on Counsel and Regulation 31 of the Legal Aid Regulations, the Registrar assigned⁸ Anni Pues to represent the five victims participating in the proceedings.⁹

II. APPLICABLE LAW

- 6. Pursuant to Rule 98(1) of the Rules, after receiving the SPO and the Defence respective Pre-Trial Briefs, lists of witnesses and lists of exhibits, as stipulated in Rule 95(4) and (5) of the Rules, the Pre-Trial Judge shall transmit to the Trial Panel a complete case file consisting of:
 - (a) The indictment as confirmed;
 - (b) All filings and material submitted through the electronic court management system;
 - (c) Any evidentiary material received not subject to paragraph (1)(b);
 - (d) Any other correspondence with respect to the case not filed with the Court Management Unit;
 - (e) A Handover Document summarising:
 - (i). the arguments of the Parties and, where applicable, Victims' Counsel on the facts and the applicable law;
 - (ii). the points of agreement;
 - (iii). a list of the orders and decisions rendered by the Pre-Trial Judge;

- (iv). the evidentiary material produced by each Party;
- (v). suggestions as to the number and relevance of the witnesses to be called;
- (vi). the questions of fact and law that are in dispute;
- (vii). the state of advancement of the disclosure process;
- (viii). all meetings with the Parties; and
- (ix). any other matter that remained unresolved;
- (f) Any application and decision concerning disclosure; and
- (g) Any other material relevant to the case.
- 7. Pursuant to Rule 98(2) of the Rules, the transmission of the case file shall be completed by means of electronic access.

III. DISCUSSION

- 8. The Pre-Trial Judge finds that all necessary procedural steps have been taken in order to consider case file KSC-BC-2020-05 complete and, therefore, ready to be transmitted to Trial Panel I, in accordance with Rule 98 of the Rules.
- 9. In particular, the Pre-Trial Judge has prepared a Handover Document, containing the information prescribed by Rule 98(1)(e) of the Rules, for the benefit of the Trial Panel and the Parties. The Pre-Trial Judge specifies that, due to the non-public information contained in the Handover Document, it cannot be made public at this stage. The Handover Document is annexed to this decision.

10. For the above-mentioned reasons, the Pre-Trial Judge hereby **TRANSMITS** case file KSC-BC-2020-05 to Trial Panel I, including the Handover Document annexed to the present decision.
