1. As ordered by the Pre-Trial Judge,<sup>1</sup> the Specialist Prosecutor’s Office (‘SPO’) hereby annexes an addendum to its latest Rule 102(3) Notice.<sup>2</sup> For each of items 99, 101-03, and 106-20 on the Rule 102(3) Notice, new descriptions provide: (i) the purpose and content of each item; (ii) the international provider involved and the confidentiality or use restrictions of the item; and (iii) the link, if any, of each item to Items 365-370 of the Exhibit List.<sup>3</sup> Only isolated information in these items is relevant to the case, but further description cannot be provided without compromising the confidentiality and use restrictions attached to them.

2. Since the Rule 102(3) Notice, the SPO has been able to match further evidence in Batch 3 with its international correspondence. Accordingly, four items have been added to the addendum annex with the same descriptions indicated in the previous paragraph.

3. This addendum and its annex are filed confidentially because they relate to filings bearing the same classification.
