1. On 18 June 2021, the Specialist Prosecutor's Office ("SPO") filed its Prosecution

Request for Extension of Time Limit to Provide its Rule 102(3) Notice, seeking to

extend the deadline for the SPO to provide the Rule 102(3) Notice to the Defence until

30 July 2021.1

2. Just eight days earlier, on 10 June 2021, in opposing the submissions of the

Defence for Mr. Krasniqi ("Defence") about the likely duration and disproportionality

of pre-trial detention, the SPO had submitted that there was no indication that the SPO

had been "dilatory" and that trial preparations were "proceeding in an expeditious

manner".2 At the time of making those submissions, it must have already been

apparent to the SPO that it was unable to meet the current deadline for providing the

Rule 102(3) Notice³ and would need to seek a five week extension. Perhaps the SPO

did not want to draw attention to this forthcoming extension request, because it so

clearly supports the Defence submission that the likely start date of trial is many

months away.

3. In any event, considering the scale of the case and in the interests of comity, the

Defence do not oppose the requested extension, and would seek an equivalent

adjustment to the deadline for the Defence to request Rule 102(3) materials (as the SPO

has already anticipated).4
