THE PRESIDENT of the Specialist Chambers ("President"), acting pursuant to

Articles 33(1)(c), 41(10) and 45(2) of Law No. 05/L-053 on Specialist Chambers and

Specialist Prosecutor's Office, Rules 58, 169 and 170(1) of the Rules of Procedure

and Evidence before the Kosovo Specialist Chambers ("KSC") and Rules 3 and 4

of the Rules on Assignment of Specialist Chambers Judges from the Roster of

International Judges ("Rules on Assignment"), herewith assigns a Court of

Appeals Panel to decide on an interlocutory appeal by Mr Pjetër Shala against a

decision by the Pre-Trial Judge related to his detention ("Appeal").1

I. PROCEDURAL BACKGROUND

1. On 15 March 2021, Mr Shala was arrested in Belgium pursuant to an arrest warrant

issued by the Single Judge on 12 June 2020² and was transferred to the Detention

Facilities of the KSC in The Hague, the Netherlands, on 15 April 2021.3

2. On 15 June 2021, the Pre-Trial Judge rejected Mr Shala's request for provisional

release ("Impugned Decision").4

3. On 28 June 2021, Mr Shala appealed the Impugned Decision.⁵

II. CLASSIFICATION

4. The Appeal is classified as confidential and the present decision will therefore bear

the same classification in accordance with Rule 82(4) of the Rules, until it is reclassified

in due course.
