1. On 2 August 2021, Trial Panel I issued the “Decision on Specialist Prosecutor’s request for segregation and other measures” (‘Decision’), ordering the Registrar to segregate Mr Mustafa and restrict his contacts with the outside world as of Thursday, 19 August 2021, at noon.¹
2. On 18 August 2021, at noon, the Decision was notified to the Defence through Legal WorkFlow.² A translated version of the Decision was issued at the same time and a hard-copy was hand-delivered to Mr Mustafa in the Detention Facilities.
3. The Registrar hereby informs the Panel that Mr Mustafa was segregated on 19 August 2021, pursuant to the terms and conditions outlined in the Decision.
4. Visits and communications of the Accused with the outside world are suspended pending submission by the Defence of the list of close relatives whom Mr Mustafa wishes to meet (by video or in person) or speak with on the phone, and the filing by the Specialist Prosecutor’s Office of any potential objections to said contacts.³ The restriction does not apply to privileged contacts with Defence Counsel and his team, nor to special visits (with the ICRC, the Ombudsperson, Registrar, Judge or Panel, or a staff member acting on their behalf).⁴

5. The Registry will report to the Trial Panel on the enforcement of the segregation regime and restrictions to communications and their eventual effects on the Accused every 30 days, or at any time earlier, if deemed necessary.⁵

6. The filing is submitted as confidential pursuant to Rule 82(4) of the Rules.⁶
