

1. On 6 September 2021, the Specialist Prosecutor's Office ('SPO') sought leave to, *inter alia*, add W04866's interview transcripts to its list of exhibits ('Request').¹
2. On 13 September 2021, revised versions of these transcripts containing minor corrections were disclosed.
3. The SPO informed the Trial Panel that these revisions would be disclosed,² but did not seek leave to add these revised transcripts separately by the 13 September 2021 deadline set by the Trial Panel.³ The reason for this oversight is that these revised transcripts concerned items whose addition to the list of exhibits was already the subject of a pending request.
4. The SPO seeks the Trial Panel's leave to have these revised transcripts considered when resolving the Request. Noting the reasons given for adding W04866's transcripts in the Request⁴ and the interest in the list of exhibits containing the most accurate version of the evidence available, the SPO hereby requests that the Trial Panel grant the Request by adding the latest versions of W04866's interview transcripts to the list of exhibits.⁵
