

I. SUBMISSIONS

1. The SPO does not object to the reclassification as public of the one excerpt identified for such reclassification in paragraph 16 of the Haradinaj Defence Request.¹ While there is certainly nothing 'astonishing' about this excerpt,² the SPO sees no reason for it to remain unavailable to the public.

2. While not objecting to the reclassification of this specific excerpt, the SPO notes that the Defence Request misstates W04841's evidence and makes unsubstantiated assertions. In particular, W04841 did not assert that she has shared a desk for years with a certain SPO staff member named by the Defence,³ and the assertion that this same staff member is or was 'leading the investigation around the Batches'⁴ is equally unsupported.

3. Further, should the Defence deem that further evidence heard in private session requires reclassification, it would assist the proceedings if the Defence could specify which excerpts it is referring to rather than extend a generic invitation to the Trial Panel to review private session transcripts with a view to reclassification or the provision of redacted versions.⁵
