I. SUBMISSIONS

- 1. Pursuant to the Decision¹ and the Order on the Conduct of Proceedings,² the Specialist Prosecutor's Office ('SPO') provides, in Annex 1, updated versions of the: (i) issues, facts and circumstances in relation to which W04876 will be examined; (ii) tentative list of (proposed) exhibits that the SPO intends to use with W04876; and (iii) summary of items to be tendered through W04876 pursuant to Rule 154 of the Rules.³ In the latter, the SPO deleted information/items related to the 9 September 2020 handover of documents, which the Trial Panel has not authorized the SPO to address during W04876's testimony,⁴ added references to translations of the two items the SPO intends to seek admission of pursuant to Rule 154, and added the Exhibit List item number for the document with ERN 102754-102755,⁵ reflecting the only update to the Exhibit List set out in Annex 2.
- 2. Disclosure of the SPO Official Note concerning a meeting with W04876 on 25 September 2021 and of the Albanian translations of the items the SPO intends to seek admission of pursuant to Rule 1546 was completed on 1 November 2021.7
- 3. In view of the Decision and unless otherwise instructed by the Trial Panel, the SPO intends to call W04876 to testify immediately following the completion of W04842's testimony.⁸
